Dear Parents:

Please find attached the forms and information package for our intermediate grades 6-8 ski trips to Hockley Valley Resort. We are scheduled for 4 days of skiing. Please note as well, this year all students will be skiing. The reason for this is that it is more practical for teachers and parents to supervise skiers. Though there is an inherent risk in alpine skiing, I feel that with everyone skiing we will be more successful in monitoring safety. In addition to this, all skiers will need to wear helmets. Students may bring their own helmets or they will be able to rent at Hockley Valley; the cost for a helmet rental is \$5/day.

The dates for skiing are:

- 1) Friday, January 17, 2014
- 2) Thursday, January 23, 2014
- 3) Friday, January 31, 2014
- 4) Friday, February 7, 2014

If the weather is poor for one of these days and the day has to be cancelled, we will try to book a make-up day. Transportation will be by Board approved school buses. However, we have arranged to have the company pick up the children early, enabling us to have more time on the hills; thus, we have a pick-up time of 7:30 am. This means that parents will have to transport their children at the school by 7:15 am on each of the days. If this is a difficulty, perhaps arrangements can be made with another family to drop your child off. We will be returning in time for the school buses to go home, therefore, parents will not have to pick-up their child; they will come home on regular school buses.

The breakdown of costs is as follows:

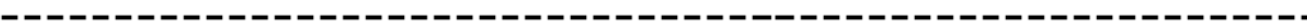
- 1) Lift, lesson, ski & helmet rental, and busing = \$180
- 2) Lift, lesson, no ski rental, and busing = \$165
- 3) When completing the forms, please submit a cheque for the appropriate amount to Josyf Cardinal Slipyj School. Cheques can be postdated for January 1, 2014. Please return the forms promptly.

Please read and complete the attached package of information, stressing the need for responsibility and safety when on the hills. This year with the introduction of mandatory helmets, we have one additional factor to safeguard student safety. With responsibility and safety, we should be able to continue a wonderful winter program for our students for this year and for the future.
