WELCOME AND PRAYER

Mr. Corkery welcomed parents and called the meeting to order. Mr. Walo led the opening prayer.

AGM REPORT

Mr. Corkery began the AGM report with a brief review of CSAC's accomplishments of the previous academic year. The list of topics covered:

1. Introduction of the Legacy Fund
 - As a direct outcome of the new Legacy Fund total donations to the school went up by 50%.
 - All items earmarked for purchase through the Legacy Fund were obtained for the school.
2. Creation of Parent Survey
 - Much time was spent by CSAC creating a parent survey last year. In the end due to various reasons, the survey was not approved and not disseminated. In the future a smaller more concise survey may be initiated. The idea behind the survey's creation is to allow for an opportunity for parents to contribute thoughts and suggestions regarding our student's educational experience.
3. Creation of Class Representative and Parent Email lists
 - Prior to Mr. Walo's arrival as Principal, much time was spent by CSAC in discussion around the feasibility of creating a system of class representatives and a parent email list. St. Anselm hosts many events throughout the year and these lists assist in ensuring that all parents who may want to be involved in a direct way are able to do so and get the information necessary on a timely basis.
4. Cookbook Sale
 - CSAC produced a school cookbook which was a tremendous fundraising success generating about \$3,000 profit for the school.

5. Special Events

- World Music Night – raised \$15,000 for the school
- Curling Night and Bottle Auction- raised \$1,500 for the school
- Welcome Back Bonanza- raised \$1,500 for the school

6. CPIC Grant, PRO Grant

- Through an application process, CSAC was able to access monies previously not applied for in the order of \$850.00. These grants are typically used to fund parent engagement events such as guest lecturers.

7. By-Laws

- Creation of St. Anselm By-Laws governing responsibilities of CSAC. These By-Laws will be posted on the school website and will be sent to the Superintendent of Safe Schools Mr. Rory McGuckin.
- These By-Laws will be ratified at next CSAC meeting.

ELECTIONS

- Mr. Walo informed gathering about nominations received.
- Mr. Corkery provided a description about the role of the positions on CSAC.
- Discussion ensued regarding voting rights. Outcome of discussion - Voting rights will be outlined in By-Laws and will be addressed at next CSAC meeting.
